**HALEDON MUNICIPAL CODE**  
**AN ORDINANCE TO REGULATE THE PARKING OR LEAVING OF ROLL-OFF**  
**DUMPSTERS AND CONTAINERS ON THE HIGHWAYS OR PUBLIC PROPERTY**  
**WITHIN THE BOROUGH OF HALEDON**

BE IT ORDAINED by the Mayor and Council of the Borough of Haledon, County of Passaic, as follows:

1. No person shall park or leave unattended any waste or refuse container, commonly known as a roll-off dumpster or roll-off container, on or along any highway or public property within the Borough of Haledon, without the written consent from the Borough of Haledon, having jurisdiction over the highway or public property within the Borough of Haledon. Consent shall be issued in the form of an official permit. The permit shall be issued by the Office of the Municipal Clerk after first being vetted by the Haledon Police Department Traffic Division. All permits issued shall be valid and remain in effect for a period of not more than seven (7) days. **The permit fee shall be \$100.00 per container.** Roll-Off Container Permit Applications shall be made available to the public by the Office of the Municipal Clerk and the Haledon Police Department.
2. To warn the operators of vehicles of the presence of a traffic hazard requiring the exercise of unusual care, any roll-off dumpster or roll-off container parked on or along any highway shall be equipped with reflective caution tape or equivalent, and reflective cones or markers.
3. A person who is convicted of a violation of this section shall pay a fine of not more than \$500.00 for each violation. In addition to the fine, the violator shall be liable for any required towing and/or impound costs.
4. All sections or parts of sections of the Code of the Borough of Haledon inconsistent with the provisions of this Ordinance, are repealed to the extent of such inconsistency only.
5. If any section or provision of this Ordinance shall be adjudged invalid, such determination shall not affect the other provisions hereof which shall remain in full force and effect to the extent that such conflicts or inconsistency provided not otherwise required by law.
6. This Ordinance shall take effect immediately upon final passage and publication as provided by law.
