The regular meeting of the Haledon Board of Health took place on June 20, 2018, Wednesday, at 510 Belmont Avenue, Haledon, New Jersey. Formal action was taken.

# **COMMUNICATIONS**

The Board received a letter of introduction from the Paterson-Passaic County-Bergen County HIV Health Services Planning Council, Chairman Mark Anderson, dated May 15, 2018 and a communication related to a May 30, 2018 NJDEP Remediation Permit to William Paterson University for 300 Pompton Road (Block 64, Lot 2), effective June 5th, provided via May 30th email from Rachel Hollingsworth of NJDEP.
