Mr. Zach Topp, 66 Cedar Cliff- we have a chicken coop on our property. We have received a summons for having the chicken coop because the Borough code prohibits it. The property has a tremendous amount of ticks and the whole family has Lyme disease. Raising the chickens assists with this health issue by reducing the amount of ticks because the chickens eat them. Approached the Mayor and Council of the Borough of Haledon and Mayor Stampone is in support of residents having chicken coops. The Borough inspector that issued the summons does know of the situation and is giving us time to address the ordinance with the Haledon Board of Health.

Board President Nadia Almaita stated that there is a process to amending the ordinance. This ordinance will be referred to the Haledon Board of Health Ordinance Committee for their review and recommendation. The process will take a couple of weeks. We could possibly amend the ordinance to allow chicken coops but with restrictions (such as the size of the property) who gave the summons and how much was it?

Board of Health Member Myla Ramirez asked if there were any noise complaints lodged due to roosters or chickens at that location.

Board of Health Secretary Leena Abaza stated she will gather all the information that is being requested and send it to the Board of Health Ordinance Committee.

Board of Health President Nadia Almaita requested from the Health Officer Mr. Persaud to explain the POD, what kind of medicine is in it and the procedure that is followed in an emergency situation.

Health Officer Mr. Persaud stated different departments are involved in the disbursement of the medicines that are in the POD. But the POD is not just used for distribution of medicine, it is a safe place to be in an emergency situation. The City of Paterson is currently working on the use of closed PODs. But Paterson needed information from the surrounding towns regarding shelters and/or companies those employee more than 100 employees.

Board of Health President Nadia Almaita stated that information on closed PODs is needed so the Board can understand the use and have a discussion on this. Requested the Board of Health Secretary Leena Abaza to
