The Board Secretary, the Registered Environmental Health Specialist, Nurse and Registrar provide reports.

Board of Health Secretary Leena Abaza mentioned in her report the two grease trap inspections that Robert Sawh the Registered Environmental Health Specialist performed at Jimmy Geez and Chef King. These inspections were initiated due to the Haledon Superintendent of Public works reporting a sewer backup in the area of these two restaurants.

Robert Sawh elaborated on the process by explaining he went to both businesses and they supplied receipts of a company picking up their grease. The businesses were both in compliance and were not dumping grease into the sewer system.

Board President Nadia Almaita questioned if the Board of Health should request proof of grease removal from the Borough's restaurants when Robert performs the Retail Food License inspections. She also wondered if we should keep record of the results.

Robert Sawh mentioned in the Borough Code this duty falls under the Department of Public Works. But we could keep record once the information is given to the DPW. Robert also mentioned that they Board of Health could make it a board policy that the business owners keep receipts of the grease collection for a year.

President Nadia Almaita requested the Board of Health secretary to open a file for grease trap inspection to put any information given to the Board in that file.
