WHEREAS, N.J.S.A. 19:44A-20.12 allows the awarding of a contract when the public emergency requires the immediate delivery of goods or performance of emergency services; and

WHEREAS, the heating and air conditioning system for Borough Hall is in need of immediate repairs to maintain proper ventilation to support and maintain municipal operations for the Borough; and

WHEREAS, that the Chief Financial Officer has certified funds in account set up for ordinance # 3-23-2023B adopted April 27 2023.

WHEREAS, a contract can be awarded without competitive bidding as an emergency affecting the public, health, safety or welfare of the Borough which requires the immediate performance of services; and

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Haledon, that the Borough Administrator/Clerk and Chief Financial Officer is hereby authorized and directed to approve repairs contract to Combustion Service Corp in the amount of \$70,000.00 for HVAC emergency repairs.
